15-Year AquaPLEX® Vessel and Heating Surfaces Extended Limited Warranty

What This Extended Limited Warranty Covers

When used for heating or storing potable water for domestic water heating purposes, this extended limited warranty covers defects in materials or workmanship of the vessel and/or heating surfaces that result in any of the following:

- · Production of Rusty or Discolored Water
- Leaking
- · Chloride Stress Corrosion Cracking
- · Leaking due to Fireside Condensate Corrosion

Repair Extended Limited Warranty

For 10 years from the start of this extended limited warranty, if the vessel or heating surfaces has a warranty-covered defect, Watts Heating and Hot Water Solutions, LLC dba PVI Industries ("PVI") will repair the defect and bring the tank or heating surfaces back to working condition. If, in the judgment of PVI, repair is not practical, this repair extended limited warranty will not be in force and the replacement extended limited warranty will be in force.

Replacement Extended Limited Warranty

For 15 years from the start of this extended limited warranty, if, in the judgment of PVI, a warranty-covered defect of the tank or heating surfaces is not repairable, PVI will replace the water heater with the then current equivalent model. The first 10 years will be at no cost to the owner for the water heater. No labor or freight will be authorized or paid by PVI. From the beginning of the 11th year to the end of the 15th year from the start of this extended limited warranty, PVI will offer to sell the owner a new water heater of the then current equivalent model. The cost to the owner for the replacement water heater will be equal to the number of months elapsed from the date of start of this extended limited warranty, divided by the total number of months of this extended limited warranty, times the then current list price. At no point will the cost to the owner for the replacement water heater exceed 75% of the current list price. No labor or freight will be authorized or paid by PVI.

Start of Extended Limited Warrantv

This extended limited warranty must be purchased separately at the time of the original product purchase. The warranty period will begin at the time of start-up or six months from date of shipment, whichever occurs first.

General Conditions

Under no circumstances will PVI pay for, or be responsible for, overtime pay (nights, weekends, or holidays) for the owner's convenience or desires. Labor cost covered by this warranty is extended limited to installations with normal access to the equipment.

All additional cost resulting from uncommonly restrictive ingress or egress requiring intricate rigging and/or unusual building or machinery alterations will be the owner's responsibility Installation and operation must comply with all applicable federal, state, and local regulations, and must be in accor-dance with applicable instructions and limitations contained in the PVI installation and maintenance manual for the product. Normal maintenance and repair shall be performed by the owner. This extended limited warranty does not cover abuse or misuse of the product. This extended limited warranty is void if modifications are made to the product without the knowledge and consent of PVI. This extended limited warranty does not cover failure resulting from the accumulation of precipitant inside the vessel. This extended limited warranty does not cover vessels or heaters used for non-domestic (process) applications or for non-potable or highpurity water. Potable water is defined as complying with the U.S. EPA primary drinking water regulations and secondary drinking water standards with the exception that the routine maintenance level of free (residual) chlorine must be ≤ 1 ppm.

This extended limited warranty is in lieu of all other warranties and guarantees, whether expressed or implied, including statutory warranties, such as warranties of merchantabil- ity or fitness for a particular purpose.

The sole and exclusive remedy is repair or replacement of defective products pursuant to the terms of this extended limited warranty.

In no event shall PVI be liable for consequential or incidental damages, or contingent liabilities or any kind, resulting from the manufacture, sale, installation, or use of this products. Some states do not allow limitations on incidental or consequential damages or on the length of an implied warranty. The above limitations may not apply to you. You may have other rights, which vary from state to state.

In no event shall PVI's liability on any claim for damages arising out of or connected with the sales contract, or the manufacture, sale, delivery, or use of the goods exceed the purchase price of the goods.

All legal actions for breach of this extended limited warranty, or the terms and conditions of the contract for sale of the product, must be commenced on or before the expiration of one year from the date of such breach. Otherwise, such action shall be considered barred by a period of limitations established by agreement. This extended limited warranty covers the first installation only. PVI shall be entitled to inspect the product prior to repair or replacement.
